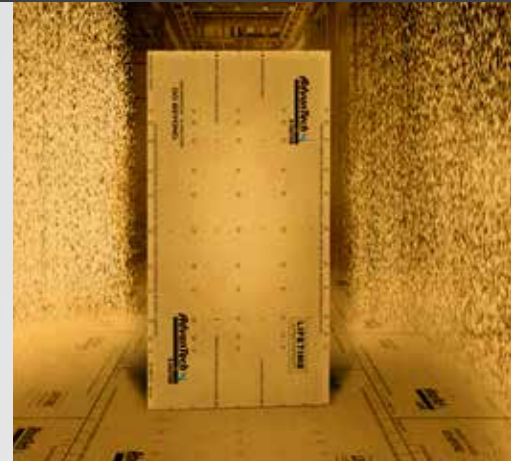

PAYMENTS TO THE QUALIFYING BUILDING COMPANY AND/OR RETAIL SALESPERSON WILL BE ISSUED WITHIN APPROXIMATELY 60 DAYS AFTER RECEIPT OF COMPLETED REGISTRATION FORM AND VALID INVOICES.
